<b>B Currency (Logbooks)^</b>

<p>Option 1:</p> <p>In order to demonstrate currency, an applicant seeking registration must have verifiable evidence of <i>instructing</i> a minimum of <b>18 hours</b> of climbing on artificial surfaces. The sessions must:</p> <ul style="list-style-type: none"> <li>be in the past twelve (12) months,</li> <li>involve different locations and/or different groups, and</li> <li>involve at least one (1) dependent client group~.</li> </ul> <p>(~ Commercial client groups or groups led by a volunteer within an organised club like environment.)</p> <p style="text-align: center;">AND</p> <p>In addition, evidence must be supplied of a minimum of <b>6 hours</b> of 'in-house' or external vertical rescue training or participation in vertical rescue of 'real' participants, within the past twelve (12) months.</p>

OR

<p>Option 2:</p> <p>Meet the currency requirements of the relevant Re-registration Table for the previous 3 years (The Re-registration Table must be filled in and included in the application)</p>

**There is a maximum of 8 logged hours per day that can be used for meeting registration requirements.**

<b>C Current First Aid and CPR Documentation*</b>

<p>* This evidence must be certified. Certified under the NOLRS means it has to be signed by somebody from the Australian Government's Statutory Declaration Signatory List.
